## Re: El Dorado County's Redistricting Alternatives

Dear Mr. Nutting/Ms. deSanchez:
Please share this letter with the entire Board of Supervisor's prior to their decision to adopt a new County district map. In addition, we respectfully request this letter be included as part of the public record on the redistricting issue when it is presented to the Board for their discussion or decision at future board meetings.

Today, (June 7, 2011) the South Lake Tahoe City Council voted unanimously to submit the following recommendation to the Board of Supervisor's for consideration in adopting a new El Dorado County District Map. During today's meeting, the City Council recognized Alternative One (1), Two (2) and Three (3) all allow the South Lake Tahoe region to remain within one El Dorado County District, which is preferred by the City Council. If the Board of Supervisor's would choose from among these three alternatives, the South Lake Tahoe City Council prefers Alternative Three (3). However, if the Board of Supervisor's is going to choose from Alternative Four (4) and Five (5), both of which split the South Lake Tahoe community among two County districts, the South Lake Tahoe City Council prefers Alternative Five (5).
