
Subject: "CAO Recommendation for 2011-2012 Budget Reductions."



Dear Ladies and Gentlemen:

We understand the difficult budget challenge facing the Board of Supervisors as you consider methods of addressing the General Fund Operating Budget structural deficit projected for 2011/12 and beyond. According to County budget analysts, unless sustainable, on-going cuts are made, next year's \$11 million operating deficit continues to grow in 2012/13 and beyond.

We urge you to retain Western Slope Shelter project funds for the Shelter project and not use these "one time" capital funds to address the County's on-going operating budget deficit. The permanent shelter is clearly needed. The Board's action in July to move the project forward in a phased approach was the right course of action. Using the capital project funds saved in prior years for a needed community asset does not solve the structural operating budget deficit. Instead, it merely buys a little time while creating future problems by stripping resources from a needed, planned project with no hope of accumulating those resources again.
