

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the District Attorney's Office has determined the addition of a District Attorney's Executive Secretary and a Special Investigator (District Attorney-[non-sworn]) is warranted in said office; and

WHEREAS, the Chief Administrative Office and Human Resources Department recommend creation of these positions; and

WHEREAS, the Human Resources Department has determined a new job class is not necessary, and that minor modifications to the existing Sheriff's Executive Secretary job specification would meet the requirements of the District Attorney's Executive Secretary; and

WHEREAS, the Human Resources Department recommends that the job title of Sheriff's Executive Secretary classification be changed to Executive Secretary (Law and Justice) to meet the needs of both offices; and

WHEREAS, the District Attorney and Human Resources Department have determined the position of Special Investigator (District Attorney-[non sworn]) will be a General Bargaining Unit employee, and salary set equal to the classification of Investigator (Public Defender); and

WHEREAS, it is necessary for the Board of Supervisors to approve the job specifications for new classifications and to adopt the salary range and designate the bargaining unit for these classifications, and to approve substantive changes in existing classifications; and

WHEREAS, in accordance with Section 202 of the El Dorado County Compensation Administration Resolution #227-84 applicable to represented employees, and Section 501 of the Salary and Benefits Resolution #323-2001 applicable to unrepresented employees, the Board of Supervisors shall by Resolution specify the number and classification of all authorized positions of each department of the County.

NOW, THEREFORE, BE IT RESOLVED, that Board of Supervisors of the County of El Dorado approve and adopt the salary range and bargaining unit designation for Special Investigator (District Attorney [non sworn]) and approve the change to the Sheriff's Executive Secretary and amend the El Dorado County Salary Schedule as listed below:
