# Minutes of Joint Parks Commission and Trails Advisory Committee Workshop on November 5, 2009

# Agenda Items and Discussion

#### 1. Review Project Plan

Kate Kirsh described the various project phases anticipated for completion of the El Dorado County Parks and Trails Master Plan (the Plan). The ten major tasks from project initiation through final adoption by the Board of Supervisors were reviewed to familiarized attendees with the approach and scope of the effort.

Anticipated duration for the project is approximately 10 months, depending on review cycles and possible expansion of public process.

Russ Nygaard also explained that the Plan will describe in general the availability of recreation resources in the Tahoe Basin, but that TRPA, the US Forest Service, and the City of South Lake Tahoe are providing and managing the parks and trails in that area. It was noted that the El Dorado National Forest has recently updated its management plan for the forest and that it may include relevant recreation information.

#### Action Item: Coordinate with South Lake Tahoe and TRPA to let them know about the Plan, and proposed approach to including Basin resources. May slightly expand scope depending on final approach. Assigned to: Nygaard

# 2. Review Public Participation Strategy

Kate Kirsh outlined the proposed public participation process and explained the timing of the various public input and review opportunities with respect to the overall project plan.

#### Web Site

Attendees were asked to provide suggestions for possible links for the Plan web site to other recreation web sites.

Kate explained that the web site would be used to communicate project events, updates, and interim deliverables for public review and comment. It was suggested that Advisory Committee members receive an email notice whenever the web site is updated so they in turn can let their contacts know to check the site.

Joint Parks and Recreation Commission and Trails Advisory Committee Meetings Kate explained that this was the first of two joint meetings of the Parks and Recreation Commission (PRC) and Trails Advisory Committee (TAC) that will be held during the project. The second meeting will focus on establishing Plan Goals and Policies.

### Master Plan Advisory Committee

Attendees were asked to provide suggestions for participants in the Master Plan Advisory Committee. Kate explained that this group would be responsible for providing consensus based guidance throughout the project and for assisting with outreach to the various interest groups. It was also suggested that key County staff, such as maintenance and planning staff, participate in Advisory Committee meetings to provide technical assistance with respect to County policies, procedures, and General Plan conformance. #### Community Workshops

Attendees requested the number of community park workshops be expanded from 2 to 4 to facilitate more comprehensive input from County residents. Several locations for the public meetings were suggested. These were Placerville, Diamond Springs/El Dorado, Pollock Pines, South County, and Coloma/Lotus. Sutter's Mill School was proposed as a facility for the Coloma/Lotus area meeting. It was determined that residents from Rescue would most likely attend the meeting for the Coloma/Lotus area, and Shingle Springs residents would attend the Diamond Springs/El Dorado area meeting. The attendees also agreed that having a separate workshop focused on trails, as planned, was worthwhile and that this meeting should perhaps be held in Placerville because it is centrally located.

#### Surveys

It was also strongly suggested that phone and written surveys, as well as a project web site, be included in the outreach strategy.

#### Key Stakeholder Interviews

Kate explained that key stakeholders are people who are likely to be influential in the planning process, but may not be available to participate throughout the project. Up to 10 key stakeholders will be interviewed individually. Suggested key stakeholder groups are:

### Public Input Meetings

Kate explained that the public would have the opportunity to provide input on the Plan at 3 public meetings separate from the Community Workshops. These meetings are envisioned to be either separate or joint meetings of the PRC, TAC, and or Board of Supervisors, and will be held to review initial analyses, the Draft Recommendations, and the Draft Master Plan.

# 3. Review Proposed Master Plan Document Outline

Kate Kirsh reviewed the proposed outline fro the Plan to familiarize attendees with the organization and scope of the plan.

# 4. Review Placerville Area Parks Master Plan Findings

The findings from the Placerville Area Parks Master plan regarding the deficit of park acreage in the unincorporated areas of the County were reviewed. A map was displayed illustrating the distribution of existing parks and parcel density to highlight which areas are most underserved.
