AGREEMENT FOR SERVICES #247-F1111 AMENDMENT I

THIS AMENDMENT I to that Agreement for Services #247-F1111, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and El Dorado Hills Chamber of Commerce, a non-profit organization, duly qualified to conduct business in the State of California, whose principal place of business is 2085 Vine Street, Ste 105, El Dorado Hills, CA 95762; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide promotional services in order to promote the local economy and enhance the quality of life in the region; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE III - Compensation for Services; and

NOW, THEREFORE, the parties do herby agree that Agreement for Services #247-F1111 shall be amended a first time as follows:

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears. Payment shall be made within thirty (30) days following County's receipt and approval of an invoice. Compensation for the period of October 1, 2010 through September 30, 2011 shall be \$92,420 and shall be payable in equal monthly installments of \$7,701.67 each. Compensation for each succeeding year during the term of this Agreement shall be adjusted up or down annually at a rate equal to the percentage change in the amount allocated by the Board of Supervisors for Promotions grants within the County Promotions Budget.

Contractor agrees that compensation provided pursuant to this Agreement shall constitute the total compensation provided by the County for the program(s) described herein for the term of the Agreement. Contractor shall not seek additional funding through the Promotions grant competitive process for said program(s) for funding cycles concurrent with the term of this Agreement.

Except as herein amended, all other parts and sections of that Agreement #247-F1111 shall remain unchanged and in full force and effect.
