

AGREEMENT FOR SERVICES #227-169-M-E2010 AMENDMENT II

This Amendment II to that Agreement for Services #227-169-M-E2010, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as COUNTY) and South Lake Tahoe Family Resource Center, (hereinafter referred to as CONTRACTOR).

RECITALS

WHEREAS, CONTRACTOR has been engaged by COUNTY to provide a Health Disparities Program in South Lake Tahoe for the Health Services Department, Mental Health Division (MHD) in accordance with Agreement for Services #227-169-M-E2010, dated June 29, 2010, and Amendment I, dated October 26, 2010, incorporated herein and made by reference a part hereof; and

WHEREAS, it is necessary to revise the line item amounts for services performed under this Agreement during FY 2010-11, while remaining within the total not-to-exceed amount established for the Agreement; and

WHEREAS, the parties hereto have mutually agreed to amend and replace *Exhibit C*, "Fee Schedule," of said Agreement;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #227-169-M-E2010, shall be amended a second time as follows:

1) Exhibit C - "Fee Schedule" shall be replaced in its entirety by Exhibit C (Amendment II) - "Fee Schedule" attached hereto and incorporated by reference herein.

Except as herein amended, all other parts and sections of that Agreement #227-169-M-E2010 shall remain unchanged and in full force and effect.
