

RESOLUTION NO. 007-2012

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO REPLACING RESOLUTION #004-2012

WHEREAS, salaries for classifications in Deputy Sheriff I/II and Sheriff's Sergeant are determined by Section 504 of the El Dorado County Charter; and

WHEREAS, classifications of Investigator (D.A.), Supervising Investigator (D.A.), Senior Investigator (Public Defender) are entitled to commensurate increases per Salary and Benefits Resolution Section 704, Resolution #227-99, and Memorandum of Understandings; and

WHEREAS, certain rounding errors in the calculation of salary rates in Resolution #004-2012 require correction; and the County has notified employee representatives of the indicated salary adjustments;

NOW, THEREFORE, BE IT RESOLVED, this resolution shall amend and replace Resolution #004-2012 and establish or maintain the following salary ranges for covered classifications, effective January 1, 2012.
