

RESOLUTION NO. 011-2012

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, salaries for classifications of Undersheriff, Captain, Lieutenant, Sergeant, and Deputy Sheriff are determined by Section 504 of the El Dorado County Charter; and

WHEREAS, classifications of Investigator (D.A.), Senior Investigator (Public Defender), and Supervising Investigator (D.A.), classifications are entitled to commensurate increases per Salary and Benefits Resolution Section 704, Resolution #227-99, and Memorandums of Understandings; and

WHEREAS, it has been determined that the classifications of Lieutenant, Captain, and Undersheriff are currently paid at or above the average salary of the classification within the comparator agencies and "at least equal to the average of the salaries for the comparable positions in the South Lake Tahoe Police Department, Amador County Sheriff's Department and the California Highway Patrol", in accordance with Section 504 of the El Dorado County Charter; and

WHEREAS, classification of Sheriff salary shall be set in accordance with Salary and Benefits Resolution Section 704, Resolution #227-99, in accordance with Charter Section 504, excluded are employees elected by popular vote, thus no increase is warranted for the elected official of Sheriff; and

WHEREAS, the Chief Investigator (D.A.) has an internal salary relationship with the class of Sheriff's Captain per El Dorado County Law Enforcement Managers' Memorandum of Understanding; thus there is no resulting increase for either classification; and

NOW, THEREFORE, BE IT RESOLVED maintain the following salary ranges for covered classifications, effective January 1, 2012.
