2.02	Addendum No. 1	Section 10-1.12 "Hot Mix Asphalt" of the special provisions inserted by Addendum No. 1 Add the following as the last paragraph under Summary: "Only the straightedge specifications of section 39-1.12 apply to this project. The Contractor must meet the straightedge test criteria after overlaying those areas of the

existing pavement that currently meet the straightedge test criteria and after overlaying the areas to be cold planed. The County understands that portions of the existing road do not currently meet the straightedge test criteria and will not meet these criteria after the overlay is placed. The Contractor shall identify and notify the Engineer of those areas that do not and will not meet the straightedge test criteria prior to placing overlay."
