### LIMITED DATA USE AGREEMENT #387-092-P-N2011 AMENDMENT I

This Amendment I to that Agreement for Services #387-092-P-N2011, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as CEDHSD) and Westat, Inc., whose principal place of business is 1600 Research Blvd., Rockville, MD 20850; (hereinafter referred to as DATA USER).

#### RECITALS

WHEREAS, DATA USER has agreed to provide research functions utilizing the Limited Data Set made available by County of El Dorado, Health and Human Services Agency, Health Services Department, in accordance with Limited Data Use Agreement #387-092-P-N2011, dated June 4, 2011, incorporated herein and made by reference a part hereof; and

WHEREAS, the Health Services Department has been reorganized and is now known as Health Services, a Department of the Health and Human Services Agency; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement and update Notice to Parties language based on the Health Services Department reorganization, thereby amending Section V. General Provisions;

NOW THEREFORE, the parties do hereby agree that the Limited Data Use Agreement #387-092-P-N2011 shall be amended a first time as follows:

- 1) All references in the original agreement to the "County Health Services Department" or "CEDHSD" shall be deemed to refer to Health Services, a Department of the Health and Human Services Agency.
- 2) Section V. General Provisions, 5.1 Term shall be amended in its entirety to read as follows:
- **5.1 Term.** The term of this Agreement shall be effective upon final signature through June 30, 2012.

## 3) Section V. General Provisions, 5.6 shall be amended in its entirety to read as follows:

#### 5.6 Notice To Parties

All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid and return receipt requested. Notices to CEDHSD shall be addressed as follows:
