Re:

TIM fee category for age- restricted development

History:

Since mid 2008, El Dorado County has considered a split TIM fee program for age restricted housing. If new fee categories are to be added, it may be best to revisit the issue as part of the entire fee program and CIP updates.

DOT will need to review the need for planned improvements currently in the fee program as not all of the planned improvements may be needed. DOT will need to work on creating new fee categories based upon the most common land uses envisioned for the County. Trip rates for all uses (existing and proposed) would be developed/reviewed to ensure that each category pays its fair share. This analysis may result in fee changes across some or maybe all categories.

Some of these new categories were discussed with DOT's TIM Fee Working Group in October 2008 and there was no consensus reached after four meetings.

Action:

Does this Board want to develop a new fee category for age restricted housing? If so, how will we arrive at a process to develop the category since the TIM Fee Working Group could not reconcile their differences?

Background:

On October 20, 2008 (Item 30. 08-1466), the Board directed the Department of Transportation (DOT) to add two new Traffic Impact Mitigation (TIM) fee categories for Age Restricted (55+) Housing with a second motion directing DOT to work with the TIM Fee Working Group (TFWG).

Working with the TFWG, DOT researched and analyzed what would be needed to add Age Restricted (AR) Fee Categories to the TIM Fee Program (Program). The Age Restricted alternatives and analysis were discussed comprehensively at four meetings of the TFWG, beginning with the December, 2008 meeting, however, no consensus was reached. TFWG members have conflicting points of view on this topic that cannot be easily reconciled, therefore, DOT cannot resolve all of the outstanding issues and concerns as directed by the Board.

Reason for Recommendation:

The current Program is comprised of twelve Land Use Types (two residential and ten non-residential) and is fair and reasonable. Any proposed change to the fee categories or fee amounts needs to be kept fair and reasonable and the Program needs to remain whole as required in General Plan Policy TC-Xa as amended by the voters with passage of Measure Y in November, 2008: "3. Developer-paid traffic impact fees combined with any other available funds shall fully pay for building all necessary road capacity improvements to fully offset and mitigate all direct and cumulative traffic impacts from new development upon any highways, arterial roads and their intersections during weekday, peak-hour periods in unincorporated areas of the county." Additionally, DOT continues to receive a number of requests or inquiries for reduced TIM fees. Granting any of these requests could impact the fiscal soundness and the fairness of the Program. Agreeing to one reduced fee request has the potential to put the Program on a slippery slope and it becomes difficult to determine where to draw the line with each additional request.

If fee categories are to be added, it may be best to revisit the issue as a part of the entire Program at the time of the five year TIM Fee major update. After revisiting land use forecasts, DOT would review the need for planned improvements currently in the Program as not all of the planned improvements may be needed. DOT would work to create new fee categories based upon the most common land uses envisioned for the County. Trip rates for all uses (existing and proposed) would be developed/reviewed to ensure that each category pays its fair share. This analysis may result in some fees going up for some categories, some going down, and some staying the same. Note that once fee categories are added, it is unlikely the County can go backward and reduce the number of categories (i.e., precedent has been set).
