Dear Supervisors.

Based on the "Analysis of Groundwater Availability and Recharge in the Sundance Project Area" report (submitted by Bill Bennett, CE, GE on November 12, 2010) I'm seriously concerned about the approval of the project without the requirement that they have their water supplied by GDPUD rather than wells.

Bennett's report does not include this years water shortage, which would additionally worsen his findings. I have a Davis weather station and have only recorded 7.8" of rain this season where 31.53" has been the mean for the past 15 years. In the past several years at least 7 surrounding resident's wells have gone dry and some have had to install water tanks because of low yield.

The approval of 28 additional Sundance lots in addition to our 72 approved lots in the Pilot View Drive Zone will double the number of wells in the immediate vicinity. This is based on the fact that that 22 of our lots are still undeveloped.

Mr. Bennett's report clearly points out the developer's "Hydrogeologic Investigation Assessment Report" deficiencies.

The Sundance project could have a serious impact upon our well water supply. I hope that you will support us by only approving this project with GPUD water instead of wells.

Bennett's in-depth study, his attention to important long-term considerations, the current research offered, and the "Sundance" applicant's faulty groundwater study conducted & submitted.

Based upon all the studies conducted, their validity and potential and real impact, and all the neighboring opposition, you will not allow this subdivision to begin under the current proposal. You must see that.
