RECITALS

WHEREAS, the Health Services Department been reorganized and is now known as Health Services, a Department of the Health and Human Services Agency; and

WHEREAS, the parties hereto have mutually agreed to extend the term of this Agreement, thereby amending Article II – Term; and

WHEREAS, the parties hereto have mutually agreed to increase the not-to-exceed of this Agreement, thereby amending Article III – Compensation for Services; and

WHEREAS, the parties hereto have mutually agreed to amend Article XV - Notice to Parties;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #301-183-M-E2011 shall be amended a second time as follows:

A2, 301-183-M-E2011

- All references in the original agreement to the "County Health Services Department" or "HSD" shall be deemed to refer to the Health Services Department of the Health and Human Services Agency.
- 2) Article II shall be amended in its entirety to read as follows:

Article II. TERM

This Agreement shall be effective May I, 2011 and shall expire April 30, 2013 unless earlier terminated pursuant to the provisions under Article XIII or Article XIV herein.

 Article III, Compensation for Services, Section 3.04 and 3.05 shall be amended to read as follows:

Section 3.04 Invoices shall be submitted to:

County of El Dorado Health and Human Services Agency, Mental Health Division Finance Unit 929 Spring Street Placerville, CA 95667 Attn: Accounts Payable

Section 3.05 Not-to-Exceed: \$380,000 over the term of this Agreement.

4) Article XV, Notice to Parties shall be amended in its entirety to read as follows:
