Re: Annual CPI Adjustment

Dear Ms. VanDelinder:

The Environmental Management Department (EMD) is in receipt of your letter dated March 26, 2011, regarding the El Dorado Disposal Service request for an annual CPI adjustment. Pursuant to Section 22.C. of the Solid Waste Services Agreement, dated August 23, 2004 and amended by the First Amendment of Solid Waste Services Agreement effective January 1, 2010, EMD will request that the El Dorado County Board of Supervisors consider a 2.4% rate increase rather than the 2.42% rate increase identified in your letter.

Using the CPI calculator located on the Division of Labor Statistics and Research website, EMD has determined that the Consumer Price Index – All Items – All Urban Consumers – California indicates a 2.4% increase for the point to point period of December 2010 to December 2011. The CPI calculator can be located at <a href="http://www.dir.ca.gov/dlsr/CAPriceIndex.htm">http://www.dir.ca.gov/dlsr/CAPriceIndex.htm</a>. I have enclosed a copy of the calculation for your reference.

It is the intent of the EMD to have this item heard by the Board of Supervisors on June 12, 2012 at 9:00 a.m. in the County of El Dorado Board of Supervisors Meeting Room which is located at 330 Fair Lane, Placerville, CA.

As a reminder per Section 22.B. of the Solid Waste Services Agreement, "The Contractor shall provide written notice to each rate payer in a form approved by the County, of the time, date and place of each hearing set by the Board of Supervisors to set rates. Contractor shall provide said notice at least ten (10) but no more than sixty (60) days prior to such date."
