Dear Gerri:

Please accept this letter as our request to put forth the 5% rate increase to garbage collection rates effective July 1st, 2012 in the area of El Dorado County in which our company services, per the contract terms.

Per the requirements of the contract, attached is an updated company-prepared break-out financial profit & loss statement for the area, using the most recent results available through the 2011 calendar year. Also attached is a schedule of the overall rate structure, reflective of a 5% increase.

As discussed, our interest is in servicing the area at a reasonable revenue level over the longer term, and we understand that your interests are to procure service availability to residents of the area with minimal yearover-year rate impact. As such, if you have any suggestions that would mutually achieve these objectives, we are open to meaningful proposals from your office, which would serve to decrease or defer the amount of increase implemented in this current year.

In our opinion, the key to lowering individual rates beyond the contract term remains in exploring the options for making service in the area mandatory, similar to adjacent areas in which the model has proven to work well. We understand that the public approval process for converting to mandatory service is involved, and we would once again encourage you to begin the exploration process in advance of the current contract term, as provided for in the current contract language.
