RESOLUTION NO. 055-2012

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

WHEREAS, the Interim Director of Information Technologies has determined that the change in technology warrants a change in skill sets that better meets the needs of the department; and

WHEREAS, the Interim Director of Information Technologies has determined that the work to be performed does not closely correspond with current County classifications; and

WHEREAS, the Interim Director of Information Technologies recommends the creation of the alternately staffed classification of Telecommunications Technician I/II; and

WHEREAS, the Interim Director of Information Technologies recommends reviving and updating the alternately staffed classification of Systems Support Specialist I/II; and

WHEREAS, it is necessary for the Board of Supervisors to approve the job specification for new classifications and to adopt the salary range and designate the bargaining unit for these classifications; and

WHEREAS, in accordance with Section 203 of the El Dorado County Compensation Administration Resolution #227-84 applicable to unrepresented employees, and Section 601 of the Salary and Benefits Resolution #323-2001, as amended, applicable to unrepresented employees, the Board of Supervisors shall by Resolution establish the salary for all authorized positions within the County; and

NOW, THEREFORE, BE IT RESOLVED, that the Board of Supervisors of the County of El Dorado approves and adopts the new classification, bargaining unit and salary range for Telecommunications Technician I/II, as well as the revised job classification and updated salary range for Systems Support Specialist I/II as listed below:
