On July 24, 2012 Kniesel Auto Collision Center appeal will come to your board to allow Kniesel to remove Condition 8 from their

Special Use Permit.

This company has known since September, 2009 that a sidewalk, curb and gutter were required before they opened for

business. They are now claiming poverty and can't afford it. They contend that it would cost them \$45,000 to put in this

sidewalk, but DOT says it will not cost more than \$18,000.

Some of the Planning Commission members say that this will be "a sidewalk to nowhere" and that statement is absolutely wrong.

This sidewalk will connect to the existing south-side sidewalk that Kniesel already has in place. Not only will this sidewalk complete

the existing south-side sidewalk, but it will be used for the following:

1. The neighborhood kids will use this sidewalk to walk on in order to catch the school bus which is at the corner

of Wild Chaparral and Crosswood Drive.

someone gets hit and injured or killed due to a lack of sidewalk on this side of the road.

We are asking your board to enforce Condition 8 which you first required of this business just as you did for the property

right across the street from Kniesel Auto Collision Center which is owned by Galen Miler. How about a little common sense

and consistency for once in El Dorado County. Thank you.
