**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**  
**RESOLUTION ADOPTING THE SECURED PROPERTY TAX ROLL**  
**TAX RATES FOR FISCAL YEAR 2012/13**

**WHEREAS**, Government Code §29100 requires the Board of Supervisors to adopt by resolution the rates of taxes on the secured roll on or before October 3 of each year.
