

The plan must be attached to this application when it is submitted for review.</li> <li>The organizers shall provide proof that the owners of the adjacent <u>business along the road closure are in agreement</u> with proposed closure. These agreements must be attached to this application when it is submitted for review.</li> <li>The organizers shall be closure. These agreements must be attached to this application when it is submitted for review.</li> <li>The organizers shall be closed closure. These agreements must be attached to this application when it is submitted for review.</li> <li>The organizers shall be closed across the County road to close the road. Barricades shall also be placed across all intersecting roads to deny access to the closed road.</li> <li><u>A 'ROAD CLOSED'</u> sign shall be placed at each barricade intersection. Each sign shall measure at least <u>48 inches</u> by 30 inches, with 8 inch black letters on a white background.</li> <li>The organizers shall remove all signs, all pavament markings or other materials immediately following the event. The organizers shall also <u>remove</u> all debris deposited by participants and spectators.</li> <li>The organizers shall provide a <u>Certificate of Insurance</u>, naming El Dorado County <u>Department of Iransportation additionally insured. In the amount of <u>51.000.000</u> (one million dollars) as required by the El Dorado County Risk Manager.</u></li> <li>To the fullest extent allowed by law the Organizer shall defend, indemnify, and hold the County harmless against and from any and ell claims, suits, losses, damages, and liability for damages of every name, kind and description, including attomey's fees and costs incurred, brought for, or on account of, injurites to readent of any person, including countractor'</li></ol>
