My doctor(s) have prescribed several medications to ameliorate the symptoms. Most of these pills come with one or more side effects. Frequently these are debilitating. I use cannabis, AKA. Pot, either singly or in combination with these other meds to deal with the actual and "phantom" pains resultant. It simultaneously effects relief for several symptoms. E.G. Pain, (actual & phantom) nausea, insomnia, hypertension. It rarely restricts other activity. Its main side effect is relaxation.

The Compassionate Use Act (prop 215) which we passed in 1996 allows me under law. to benefit from the properties of this substance. Cannabis has an 8000+ year history of multiple beneficial uses. Until dominant financial interests conspired to profit fraudulently from the marijuana tax act of 1937 (prohibition 2), it had many uses (canvascannabis). As an early proponent of prop 215, having worked with the principals, I can testify to the foregoing.
