AMENDMENT I TO FACILITY USE AGREEMENT # 209-O1111

SHERIFF'S POLLOCK PINES SATELLITE STATION

THIS AMENDMENT I to that Agreement #209-O1111 entered into by and between the COUNTY OF EL DORADO, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and the EL DORADO COUNTY FIRE PROTECTION DISTRICT, whose principal place of business is 4040 Carson Road, Camino, California 95709 (hereinafter referred to as "DISTRICT");

WITNESSETH

WHEREAS, the COUNTY has entered into an Agreement with DISTRICT for the use of certain real property for the purpose of operating a Sheriff's Outreach Program in the Pollock pines area, in accordance with Facility Use Agreement #209-O1111, dated January 25, 2011, incorporated herein and made by reference a part hereof; and

WHEREAS, the COUNTY desires to continue utilizing those portions of the PROPERTY described in the original Facility Use Agreement for the purpose of operating the Sheriff's Outreach Program in Pollock Pines, California; and

WHEREAS, the parties hereto mutually agree to extend the term of the Agreement for one (1) additional one (1) year period hereby amending Section 7.; and

WHEREAS, the parties hereto mutually agree to amend Sections 10. and 17.

NOW, THEREFORE, the parties do hereby agreement that Facility Use Agreement #209-O1111 shall be amended a first time as follows:

7. This Agreement shall commence on December 1, 2010, provided however, that this Agreement has been fully executed by the DISTRICT and the COUNTY, and shall cover the period of December 1, 2010 through December 1, 2013, as amended, unless said term is extended, by mutual agreement in writing not less than thirty (30) days prior to the expiration date.
10. **NOTICES:** Except as otherwise expressly provided by law, any and all notices or other communications required or permitted by this Agreement, shall be in writing and be deemed duly served and given when personally delivered to the party whom it is directed or, in lieu of such personal service, when deposited in the United States mail, first-class, postage prepaid, addressed to:
