Most of our attorneys have been practicing criminal/juvenile law exclusively for more than ten years. Our entire staff would be available to fulfill our obligations to Alpine County. However, my long time associate, Ken Bonham, and I would be specifically assigned to handle the Alpine County caseload. Mr. Bonham and I have each been active members of the California State Bar for more than twenty-five years. - 2. Relevant criminal and juvenile experience: All of our attorneys have extensive experience in both criminal and juvenile matters. Mr. Bonham and I have each handled hundreds of felony, misdemeanor, juvenile conservatorship, and dependency matters.
- 3. Continuing Education in Criminal/Juvenile Law in last 2 years: All of our attorneys regularly attend continuing education courses in criminal/juvenile law and are up to date with respect to the MCLE requirements of the State Bar. accommodate the Alpine County court schedule as outlined in your Request For Bid letter. Moreover, I am confident that with the number of staff available in our office, we could adjust to most any scheduling changes that the Alpine County Court may deem necessary. With respect to access to the clients, our office in South Lake Tahoe is located in the same complex as the El Dorado Jail where in custody Alpine County defendants are housed.

With respect to the other points raised in your letter, I would note the following:

- The performance expectations outlined in your letter are appropriate and acceptable including appearances at arraignments.
- The proposed annual fee of \$50,000 is acceptable:
- The proposal to address compensation for complex matters and requests for investigative/expert assistance on an ad hoc basis is acceptable;
- The proposal to negotiate appointments on any appellate matters which the Public Defender may accept on a separate basis is acceptable.

In discussing this matter with the El Dorado County CAO, she wanted to make certain that this agreement did not require El Dorado County to provide conflict counsel in the event that my office was unable to represent an Alpine County client due to a conflict of interest.
