Recognition for our Performance

- For FFY 2011-2012, El Dorado
 County Department of Child
 Support Services ranked in the top
 percent of the State.
- Performance ranking is based on comparison to other California counties.

Paternity

- In cases where a child is born out of wedlock and paternity is in question, Child Support Services must establish paternity of the child by obtaining an order or obtaining a paternity declaration.
- El Dorado County ranked #6 statewide in this performance measure.

Cases with Court Orders

- Child Support Services is required to obtain a court order for paternity (if at issue), child support, and medical support.
- El Dorado County ranked #5 statewide in this performance measure.

Collections on Current Support

- When monthly support is ordered to be paid, our performance is based on the amount of current support collected when compared to the total amount due.
- El Dorado County ranked #13 statewide in this performance measure.

Collections on Arrears

- Receipt of a payment on past due child support causes the county to receive credit in this performance category.
- El Dorado County ranked #4 statewide in this measure.

Cost Effectiveness

- Counties are ranked for this measurement by comparing the amount collected to the cost of running the program.
- El Dorado County ranked #29 statewide in this performance measure

 After combining ALL performance results, El Dorado County ranked #5 overall statewide.

- El Dorado County also out-performed the other 50 counties/regions in improved distributed collections.
- El Dorado County improved 13.8% in collections over the prior year with collections of \$13,291,985.

- Although cases do close due to payment in full or for other mandated reasons, at the same time new cases are opened daily.
- During the FFY, 1088 new cases were opened.
