AGREEMENT FOR SERVICES #035-S1111 AMENDMENT 2

THIS AMENDMENT 2 to that Agreement for Services #035-S1111, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") acting by and through County Service Area No. 10, a lawfully established County Service Area as defined by government Code Section 25210 et seq., and 21st Century Environmental Management of California, LP, a wholly-owned subsidiary of PSC, LLC, duly qualified to conduct business in the State of California, whose principal place of business is 535 Getty Court, Suite H, Benicia, California 94510, and whose Agent for Service of Process is CSC – Lawyers Incorporating Service Post Office Box 526036, Sacramento, California (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to collect, process, transport and dispose of household hazardous waste for the Environmental Management Department, in accordance with Agreement for Services #035-S1111, dated May 11, 2010, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the Term of Agreement for Services #035-S1111, hereby amending ARTICLE II – Term; and

WHEREAS, the parties hereto desire to amend Agreement for Services #035-S1111 to change the compensation for services, amending **ARTICLE III - Compensation for Services**;

NOW, THEREFORE, the parties do hereby agree that Agreement for Services #035-S111 shall be amended a second time as follows:

ARTICLE II

Term: This Agreement shall become effective May 22, 2010 and shall expire on December 31, 2014.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears. Payment shall be made within thirty (30) days following County receipt and approval of itemized invoice(s) detailing services rendered. For the purposes hereof, the billing rate shall be in accordance with Exhibit "A", marked "Disposal Costs", incorporated herein and made by reference a part hereof. The total amount of this Agreement SHALL NOT EXCEED Four Hundred Forty Thousand dollars (\$440,000).
