AGREEMENT FOR SERVICES 628-S1210 AMENDMENT I

THIS AMENDMENT I to that Agreement for Services 628-S1210, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Dignity Health Medical Foundation, a California nonprofit public benefit corporation, whose principal place of business is 3400 Data Drive, Rancho Cordova, CA 95670 (hereinafter referred to as "Contractor") whose Agent for Service of Process is Ian A. Boase, 3400 Data Drive, Rancho Cordova, CA 95670.

RECITALS

WHEREAS, Contractor has been engaged by County to provide inpatient acute psychiatric services, in accordance with Agreement for Services 628-S1210, dated March 8, 2013, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, amending Article III – Term and increase the maximum obligation of the Agreement, thereby amending Article IV – Compensation for Services;

NOW THEREFORE, the parties do hereby agree that Agreement for Services 628-S1210 shall be amended a first time as follows:

1) Article III shall be amended in its entirety to read as follows:

ARTICLE III

Term: This Agreement shall become effective February 22, 2012 through June 30, 2015 unless earlier terminated by one of the parties pursuant to the provisions under the Articles titled "Fiscal Considerations" and "Default, Termination, and Cancellation" herein.

- 2) Article IV, Section E shall be amended in its entirety to read as follows:
- E. <u>Not to Exceed</u>: Compensation for services provided shall not exceed \$200,000 annually, for the term of this Agreement.

Except as herein amended, all other parts and sections of that Agreement 628-S1210 shall remain unchanged and in full force and effect.
