# **DID YOU KNOW?**

El Dorado County Ordinance #4262 requires the collection and payment of a ten percent (10%) transient occupancy tax (TOT). Also, please note: all transient occupancy taxes collected are to be "held in trust", meaning you are required to collect and hold taxes and remit the taxes to the County along with the quarterly TOT tax return. (Ordinance Sections: 3.28.030 Imposed, 3.28.050 Operator Duties, and 3.28.070 Reporting and Remitting).

Delinquent penalties and interest apply if the tax is not remitted as required for each quarter. All transactions are subject to audit.

## A TOT Quarterly Tax Return is required as follows:

<u>Calendar Quarter</u> January, February, March April, May, June July, August, September October, November, December Delinquent after: April 30th July 31st October 31st January 31st

If no transient occupancy occurs and no tax is collected during a quarter, a "no receipts" tax return <u>must be</u> filed with the Tax Collector's Office indicating no receipts for the period.

### Helpful Information

- Line 1 on the Quarterly Tax Return is the total of receipts from room rentals including the cleaning fees do not include the security deposit on the rental.
- Please note: If you are operating a Vacation Home Rental on the West Slope of El Dorado County, you are required to possess a valid business license and an El Dorado County Transient Occupancy Registration Certificate.
