### AMENDMENT NO.1 TO AGREEMENT

- 1. CALTRANS and COUNTY, collectively referred to as PARTNERS, entered into Agreement No. 03-0490, (AGREEMENT) on October 18, 2012, defining the terms and conditions for the construction of new 8-foot wide Class I bike paths along the west side of State Route (SR) 49 from Cave Valley Road to SR 193 and along the north side of SR 193 from SR 49 to American River Trail for a total length of 1.8 miles, will be referred to hereinafter as PROJECT.
- 2. AGREEMENT established the roles and responsibilities for PROJECT Plans, Specifications, and Estimate (PS&E), Right of Way (R/W), Construction and its funding summary.
- 3. PARTNERS have agreed to enter into this Amendment (03-0490 A-1) in order to reflect COUNTY's funding changes (increasing of funds from \$3,147,500 to \$3,995,374) as shown on the revised funding summary. Cost increases were due to design revisions to lessen environmental impacts, R/W work that required complicated utility easements and utility relocation work, construction management tasks increased to recognize the complexity of construction staging and possible two seasons of construction.

# **IT IS THEREFORE MUTUALLY AGREED:**

- 1. A revised funding summary is attached and made part of the AGREEMENT. Any reference to the funding summary in the AGREEMENT is deemed to refer to the revised funding summary attached herein.
- 2. All other terms and conditions of the AGREEMENT shall remain in full force and effect.
- 3. This AMENDMENT is deemed to be included and made part of the AGREEMENT.
