AGREEMENT FOR SERVICES #606-M1210 AMENDMENT II

This Amendment II to that Agreement #606-M1210, is made and entered into by and between County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Provider"), and Regents of the University of California (hereinafter referred to as "University") on behalf of its U.C. Davis Health System (hereinafter referred to as "UCDHS").

RECITALS

WHEREAS, UCDHS provided equipment specific to the provision of telemedicine to Provider for use in Placerville, thereby fulfilling the intent of Proposition 1D funding by facilitating mental health services in the medically underserved areas of the County, in accordance with Agreement for Services #606-M1210 dated May 3, 2011, and Amendment I to that Agreement dated July 24, 2012; and

WHEREAS, UCDHS desires to (1) terminate Agreement 606-M1210 effective September 30, 2013, thereby amending Section 3 "Term and Termination" and (2) relinquish ownership of the telemedicine equipment described herein to the County of El Dorado upon termination of Agreement 606-M1210, thereby amending Section 1 "Acknowledgements and Responsibilities; and

WHEREAS, UCDHS and Provider (collectively the "Parties") agree to terminate Agreement #606-M1210 and transfer ownership of the telemedicine equipment described herein to Provider; and

WHEREAS, County intends to relocate the Mental Health office currently at 670 Placerville Drive, Placerville, CA 96557 during the month of October 2013, thereby amending and replacing Exhibit A-1 to reflect the new location;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #606-M1210 shall be amended a second time as follows:

- 1) Section 1, paragraph 1.1, subparagraph (a) shall be amended in its entirety to read as follows:
- (a) General. UCDHS shall, at its own expense, use reasonable efforts to (i) furnish Provider with the equipment listed in Exhibit A ("Equipment), (ii) furnish Provider's personnel with training (via video or other means) regarding use of Equipment, (iii) purchase and maintain a three-year maintenance agreement ("Maintenance Agreement") for select Equipment. The Equipment shall be and remain, at all times during the term of this Agreement, the property of UCDHS, and upon the termination or expiration of this Agreement UCDHS shall relinquish ownership of Equipment to County of El Dorado Health and Human Services

Agency for continued use by the Mental Health Division. After ownership has been relinquished to the County of El Dorado Health and Human Services Agency, UCDHS shall have no further liability for the Equipment, including, but not limited to, designated use, insurance, maintenance, support or training.

- 2) Section 3, paragraph 3.1 shall be amended in its entirety to read as follows:
- **3.1 Term.** This Agreement shall commence on May 9, 2011 and shall remain in effect through September 30, 2013.
- 3) Exhibit A-1 shall be replaced in its entirety by Exhibit A-2, attached hereto and incorporated by reference herein.

Except as herein amended, all other parts and sections of that Agreement #606-M1210 and any amendments thereto shall remain unchanged and in full force and effect.
