## EDSO - CA Public Records Act Request

Pursuant to my rights under the California Public Records Act (Government Code Section 6250 et seq.), I ask to obtain an appointment with the El Dorado County Sheriff's Office to examine the contents of the following EDSO case files:

1. El Dorado Sheriff Office Case #13-6887 – Coloma Resort
2. El Dorado Sheriff Office Case #8049 – Coloma Resort

It is requested that your determination be made within **10 days** as stipulated within the California Public Records Act.

In regard to the typical **\$10 fee** charged for copies of EDSO records, please note that AB 1234 Ethics Training – Fees for Duplication of Records: Agencies may charge the direct cost of producing a copy of a record.

The direct cost of duplication includes the pro-rata (proportionate cost) of copying equipment as well as the pro-rata cost of the person running the equipment (a proportion of their salary and benefits, for example).

The direct costs of duplication *do not* include costs affiliated with the research, retrieval, or redaction of a record as the Sheriff indicated on September 18th. An agency cannot charge a person requesting copies of records for these costs. **The theory is that these costs must be born by the agency as part of its duty to serve the public.**

If you determine that some but not all of the information is exempt from disclosure and that you intend to withhold it, I ask that you provide a signed notification citing the legal authorities on whom you rely.

To quote our Constitutional Sheriff D'Agostini, "...Hold their feet to the fire. Mine too. I work for you."

Weekly citizens come before the BOS to conduct the people's business. Rarely do they receive a response to legitimate questions that the public has a right to know. Or, as was the case on August 27th, Chairman Briggs called a recess and walked out of the room without cause when challenged about his lack of transparency & accountability to constituents.

During Open Forum last week I delivered a very serious message when I reminded the Board that silence is consent. Consent means to acquiesce, agree, permit or allow. Supervisor Mikulaco's mocking and exaggerated Cheshire cat grin was very disturbing and disrespectful. The week before Counsel was caught on video winking at reporter Chris Daley regarding LUPPU issues.

On August 27th I submitted to the Board two California Public Record Act requests for information which the law says you are required to respond within 10 days. Two days delinquent I received a partial response via electronic transmission from the Clerk to the Board combining both CPRAs into a chaotic mess.

Such conduct by public servants raises more questions about the function of El Dorado County leadership than it answers. Was the intention to deliberately deceive, was it a matter of staff incompetence...or is it just the typical BS—Bureaucratic Shenanigans?

We do not silently consent to abuse by elected representatives. Counsel, you've also taken an oath of office. We are concerned about the demonstrated inconsistencies of our elected representatives. An explanation is in order. Would you please respond for the record?

Supervisor Briggs demonstrated the same disrespect for constituents he showed Sheriff John D'Agostini and retired Marine Norm Mahalich back in March 2011. That PR Pond video of the "Petulant Supervisor" made the evening news throughout the greater Sacramento region and those videos have been viewed more than 10,000 times!

Chairman Briggs, back in May you publicly committed to respond to me in writing concerning the lack of policy consistency and the timely posting of BOS minutes. On June 25th you were reminded that a written response explaining the BOS deviation from the former practice of listing names & topics in the minutes was expected no later than the end of business day, June 28. There appears to be a **double standard**, or at best, staff incompetence... Perhaps there's more going on than meets the eye... ???

Before I continue, permit me to remind the Board of your fiduciary obligations and the criminal sanctions as they pertain to the Brown Act and Board minutes...

I'd like to cite a few excerpts from the 15-page notarized affidavit submitted to the **2010 Grand Jury re: May 2010 RMAC Brown Act meeting with Ron Briggs, County Counsel Mike Ciccozzi & Mtn. Democrat reporter Chris Daley:**

(35) Ciccozzi: "... *The legislative body has the right to approve the minutes, as long as they don't abuse it. **The public may request corrections, but RMAC is under no obligation to do so... They are your minutes, to your liking as long as they reflect the substance of the meeting as a broad brush, not a fine point.***"

**(\*\*It's noteworthy that on several occasions I'd appropriately requested corrections to the minutes but they had been denied and deliberately falsified.)**

(36)...*"The legislative body need not even hear what the public wants. The rights of the public are to address what's on the agenda. Nothing says the legislative body must listen to it, adopt it or put it on the agenda... The Brown Act is designed to ensure people's business... The Board of Supervisors, City Council, RMAC are controlled so the public can participate. RMAC must do so fairly and with decorum. They are your proceedings."*

(72) I emphasized this section of the Brown Act reinforces the right to brief discussion **"to permit a member of the public to raise an issue or problem with the body, or to permit body to provide information to the public, provide direction to its staff, or schedule the matter for a future meeting."**

(65) Briggs: "... ***It's a lot of hard work and you eat a lot of crap for free... You're an extension of the BOS and County.... If someone is saying something that is not correct, you need to protect yourselves. Go hire a lawyer. If someone is***

***continuing the County would probably assist and would seek a restraining order. The public's business has to be conducted..."***

**(\*\*Briggs was falsely insinuating that I was the problem.)**

***(68)...“I think, speaking for myself as a Supervisor, I’m going to give you as much support as I can...I want to help defend you...I don’t want you guys to worry that you’re going to get your names flashed all over the paper or someone is going to say something that is not flattering or untrue. I would eagerly help use the County resources to help prosecute your wish for RMAC and the RMP.”***

***(82)...(After an interruption a State employee) remarks, “Any other public comments that anyone would like to address on the Brown Act?” (No response) He continues, “Mike, we appreciate your being here...and very eloquently spoken, as usual.”***

**(83) Ciccozzi retorts with a laugh, “That’s why Ron hired me!”**

1. When may I expect a written explanation why my name has been obscured from BOS attachments & the requested changes not made? **(\*cited below)**
2. Explanation for the obvious wink given by County Counsel Ed Knapp to reporter Chris Daley during the Consent portion of 8/27/13 meeting?
3. CAO Form Request for Agenda Item...May we anticipate one for the BOS?

Thanks for your reply, but there are more issues at stake than meet the eye...

1. The 8/20 BOS video does not enable the viewer to click on Open Forum when some very significant issues were addressed to the BOS. The video jumps immediately to Item #17 --Prostate Cancer. The only way the public can view the 8/20 Open Forum is to watch from the very beginning @ 8:00 AM. The video appears to be deliberately edited and/or obscured. What's the explanation???
2. Additionally, the Open Forum items still do not mention the topics addressed by the speakers. (My 8/20 topic should be listed as: **BOS Breach of Fiduciary Obligation & Oath of Office**.) Why hasn't this been corrected as requested on numerous occasions?
3. Also note I addressed this matter during the 8/27 BOS Agenda Approval & Consent when Chairman Briggs illegitimately called a 5 minute recess and exited the room after his feet were held to the fire. Sheriff D'Agostini & Vern Pierson witnessed his repeat performance of arrogant disrespect for his Oath of Office. During the recess Supervisors Veerkamp & Santiago both assured me that Jim Mitrisin was supposed to get back to me regarding the lack of consistency in the labeling of the Open Forum topics.
