### AGREEMENT FOR SERVICES #007-S1411 AMENDMENT I

This Amendment I to that Agreement for Services #007-S1411, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and 3M Electronic Monitoring, Inc., a wholly-owned subsidiary of 3M Company, a Delaware Corporation, duly qualified to conduct business in the State in the State of California, whose principal place of business is 1838 Gunn Highway, Odessa, FL 33556, and whose Agent for Service of Process is C.T, Corporation System, 818 W. Seventh Street, Los Angeles, CA 90017 (herein after referred to as "Contractor");

### RECITALS

WHEREAS, Contractor has been engaged by County to provide electronic monitoring and Global Positioning System (GPS) tracking equipment and Services for the Probation Department in accordance with Agreement for Services #007-S1411, dated June 25, 2013, and incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to incorporate the WSCA-NASPO (Western States Contracting Alliance-National Association of State Procurement Officials) Cooperative Purchasing Organization Master price Agreement with 3M Electronic Monitoring, Inc., Washington Contract Number: 00212 (hereafter Exhibit "B" Participating Addendum) into Agreement, hereby amending ARTICLE I Scope of Services; and

WHEREAS, the parties hereto have mutually agreed to amend ARTICLE III Compensation for Services by incorporating Exhibit "B" Participating Addendum as best daily fees shall be based on the cumulative number of units in use with all participating government agencies participating in Washington Contract Number 00212; and

WHEREAS, the parties hereto have mutually agreed to incorporate ARTICLE XXVII Audit by California State Auditor, into Agreement for Services #007-S1411; and.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services #007-S1411 shall be amended a First time as follows:

### ARTICLE I

Scope of Services: Contractor agrees to provide electronic monitoring and Global Positioning System (GPS) tracking equipment and services for the Probation Department. Services shall include, but not be limited to, the central computer hardware and software necessary for the operation of Probation's twenty-four (24) hours monitoring of adults and juveniles on the court ordered electronic monitoring program. Services shall be in accordance with 007-S1411, Amendment I, Exhibit "B," marked "PARTICIPATING ADDENDUM, WSCA-NASPO Cooperative Purchasing Organization," Washington Contract Number 00212 incorporated herein and made by reference a part hereof.

Services/products available on an "as needed" basis included, but are not limited to, electronic monitoring, random/scheduled tracking, alcohol monitoring, with or without an offender funded program, satellite monitoring with remote tracking services (passive and active tracking), and support. Contractor shall supply an inventory of spare participant equipment and delivery at no additional cost to the County. If County requires expedited shipping, County will pay for entire shipping cost. The quantity supplied shall be equal to 15% of the department's active units.

#### ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears and within thirty (30) days following the County's receipt and approval of itemized invoice(s) identifying services rendered. County shall be invoiced the best daily fees based on the cumulative number of units in use with all government agencies participating in the WSCA-NASPO Cooperative Purchasing Organization, Washington Contract Number 00212. Total amount of this Agreement shall not exceed \$90,000.00.

### ARTICLE XXVII

Audit by California State Auditor: Contractor acknowledges that if total compensation under this agreement is greater than \$10,000.00, this Agreement is subject to examination and audit by the California State Auditor for a period of three (3) years, or for any longer period required by law, after final payment under this Agreement, pursuant to California Government Code §8546.7. In order to facilitate these potential examinations and audits, Contractor shall maintain, for a period of at least three (3) years, or for any longer period required by law, after final payment under the contract, all books, records and documentation necessary to demonstrate performance under the Agreement.

Except as herein amended, all other parts and sections of that Agreement #007-S1411 shall remain unchanged and in full force and effect.
