SUMMARY OF PROPOSED ORDINANCE
ORDINANCE NO. 4981
THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:
Chapter 3.12 of Title 3 of the County Ordinance Code titled Procurement repeals former Chapter 3.12 of title 3 on the same subject titled Procurement and adds a new Chapter 3.12 with major components as follows.
Chapter 3.12 contains a number of definitions which generally define the subject matter that is regulated, including definitions for the methods of competitively bidding supplies, materials, goods, furnishings, equipment, and other personal property through formal and informal bids and services through requests for proposal.
The ordinance designates the Chief Administrative Officer or designee as the Purchasing Agent for the County and sets forth the duties of that individual, provides for the delegation of limited authority to department heads, establishes a code of ethics for all procurement, continues the central stores account, and set forth the method for disposal of surplus property. The ordinance details the method for competitive bidding, and provides enumerated exceptions from competitive bidding including in the case of emergency.
Introduction of this Ordinance will be heard by the Board of Supervisors on August 21, 2012, in the Board Meeting room, 330 Fair Lane, Placerville, California. This ordinance shall take effect thirty (30) days following the adoption hereof.
