This evening the River Management Advisory Committee will be meeting at the Lotus Firehouse. On the Consent Agenda is the approval of the November 19, 2013 minutes of the Annual meeting held at the Marshall Gold Discovery Historic State Park. Despite reading and submitting my written comments I found that once again my Public Comments have been censored however all other public comments were included in the minutes. The minutes simply read, "Ms. Lane submitted written comments which were received" but they were eliminated from the record.

As you have been made aware, censorship is a reoccurring problem that has been ignored by the BOS for several years. This past year my comments were particularly relevant to the Personnel Policies addressed during last week's Special Board meeting and the Sheriff's role in the River Management Plan:

Despite innumerable requests, River Recreation Supervisor Noah Triplett appears to have a difficult time adhering to EDC Personnel Rules adopted by the Board May 7, 2013, specifically Sections 101 through 106. Could this be incompetence or is it deliberate deception?

It seems Sheriff D'Agostini also needs to be reminded that he works for US...

The Sheriff has not responded, and as you heard last week, he has blocked me from sending any emails to his department. That is not acceptable behavior for a public servant or elected official.

Since this is a personnel issue that needs to be remedied, how does the Board suggest this be handled and from whom can I expect to receive a response?

Over the past year EDC has experienced a crisis in the lack of ethics, transparency and accountability particularly as it pertains to the topic of tonight's annual RMAC meeting. Just because County Counsel claims an action is 'legal' does not mean it is ethical. To name just a few the issues include the following:

- 1. Deliberate censoring and falsification of RMAC minutes by county staff
- 2. CA Public Records Act violations
- 3. Brown Act Violations
- 4. Lotus-Henningson Park
- 5. Bully tactics & retaliation
- 6. Conspiracy Against Rights
- 7. Lack of proper resident representation on RMAC issues
- 8. BLM
- 9. Lack of code & law enforcement relevant to campgrounds in the SFAR Quiet Zone

In regard to the last matter of Code & Law Enforcement, Section 6 of the RMP is very specific. It addresses State, County and departmental coordination as it pertains to jurisprudence, or *Common Law* to be exact. Our meetings with the Sheriff and County staff have been for the purpose of identifying resident's concerns, correcting and adhering to the laws and ordinances to ensure those issues are properly addressed according to the LAW.
