Please see these photos are entered into record and presented at the The Board of Supervisor's for the Agenda item for Wilson MND. The photos were taken after the cars were moved from Green Valley to the entrance of Sterlingshire. These rear end accidents are too frequent at this location due to traffic making lefts into Sterlingshire entrance from westbound GreenValley Road which will be greatly exacerbated by the traffic being proposed by the addition of projects along Green Valley without widening and turn lanes added to Green Valley for this length of roadway along the project frontage and extending across Sterlingshire County Roadway Easement.

I ask the County to address these safety issues, the existing Level of Service F intersections, the circulation issues to Malcomn Dixon Road and detail the offsite improvements needed at occupancy before approving a project.
