My office has been retained by the owners of the Wilson Estates property and the applicants for the tentative subdivision map which is scheduled for the Board's agenda on March 12,2013 . We understand that there will not be a full Board for the March $12^{\text {th }}$ hearing and would have sought a continuance based on the importance of having a full Board for this important project. However, we have discussed actions that may be available to ameliorate some of the concerns raised by members of the community. One of the actions suggested, and briefly discussed with County staff, is a development agreement, which would provide assurances to the County and the community that the project as proposed will be constructed in accordance with the current project description and the proposed conditions and mitigation requirements.

In order to have the time to explore the possibility of the development agreement and other actions which may resolve some of the controversy that the project seems to have generated, we respectfully request that the matter be continued off calendar, to be re-noticed at a future time. We hope that this time will allow us to present a final project that will be embraced by the community.
