



**RESOLUTION NO. 017-2013**

**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**WHEREAS**, the State of California Department of Community Services and Development has offered Agreement 13F-3009 to the County of El Dorado and has initially made funds available in the amount of \$72,737, a portion of the projected total allocation of \$269,616, through said Agreement for Community Services Block Grant services during the period January 1, 2013 through December 31, 2013; and

**WHEREAS**, should the County of El Dorado accept Agreement 13F-3009 from the California Department of Community Services and Development, the County certifies that all uses of funds will be in compliance with Department of Community Services and Development regulations, guidelines and agreement provisions; and

**WHEREAS**, the County of El Dorado Board of Supervisors has designated the El Dorado County Health and Human Services Agency to administer programs on behalf of the County that benefit low-income populations and is willing to accept the aforementioned agreement; and

**WHEREAS**, the Chair of the Board may act on behalf of the County of El Dorado and shall sign all necessary documents required to complete the agreement.

**NOW, THEREFORE, BE IT RESOLVED THAT** the Board of Supervisors of the County of El Dorado hereby authorizes the Chair of the Board to execute Agreement 13F-3009 and the accompanying Contractor Certification Clauses CCC-307, with the California Department of Community Services and Development for the period January 1, 2013 through December 31, 2013 in the amount of \$72,737 for the provision of Community Services Block Grant (CSBG) services in accordance with the 2012-13 CSBG Community Action Plan and further authorizes the County of El Dorado Health and Human Services Agency Director, or successor, or the Chief Assistant Director, or successor, to execute further documents relating to Agreement 13F-3009, including one or more amendments thereto, contingent upon review and approval by County Counsel and Risk Management, that collectively increase the dollar amount by up to \$196,879 to the total estimated 2013 allocation of \$269,616, and other amendments thereto that do not alter the total maximum dollar amount or term; and to sign subsequent required fiscal and programmatic reports and to perform any and all administrative responsibilities in relationship to said Agreement.
