WHEREAS, HHSA/PHD shall reduce the SAPT Federal Block Grant Discretionary Funding for FFY 2011-12 by \$20,000, and increase SAPT Federal Block Grant Discretionary Funding for FFY 2010-11 by \$20,000, thereby amending <u>Article IV – Compensation for Services, Section 4.02 – Amount of Funding, subparagraph (a) (ii); and</u>
