#### ADDENDUM TO PARADE PERMIT APPLICATION

This running event is a fundraiser for the Sugarloaf Fine Arts Camp Foundation. The event will consist of three course lengths: 5K, 10K, and 10 miles on the Eastern section of the El Dorado Trail beginning at the Jacquier Road (Camellia Lane) trailhead. We hope to have approximately 350 runners.

- 1. Attached is a map indicating where road closures are being requested (only applicable for the 10 mile start/finish). 10 mile runners will run along Jacquier Road to Smith Flat Road to Smith Flat Schools Road and then on to the trail. The return route for the 10 miles will include the same, only in reverse (Smith Flat Schools Road to Smith Flat Road to Jacquier Road to the finish line in the parking lot). The roads will not be closed to residents.
- 2. The El Dorado County Explorers will provide crossing guards for each major cross street. We have spoken with Officer Rodriguez; we will have 10 Explorers and up to 3 CHP Officer Advisors.
- 3. Traffic will be held at each intersection while runners pass. Flaggers will monitor and direct traffic flow.
- 4. Traffic will be stopped beginning at 7:30 AM in advance of the 10 mile start time (8:30 AM).
- 5. Flaggers and cones will be located at each intersection:
  - a. Camellia Lane/Jacquier Road
  - b. Jacquier Road/Smith Flat Road
  - c. Smith Flat Road/Smith Flat Schools Road
- 6. Signage indicating the date and time of the road closures for the event will be posted at the following locations one week prior to the event (no later than March 22, 2014):
  - a. At the west trailhead entering Smith Flat Road
  - b. In the Camellia Lane parking lot
  - c. Near each intersection:
    - i. Camellia Lane/Jacquier Road
    - ii. Jacquier Road/Smith Flat Road
    - iii. Smith Flat Road/Smith Flat Schools Road
