MEMORANDUM OF UNDERSTANDING AMENDMENT 2

BETWEEN THE COUNTY OF EL DORADO

AND

STATE OF CALIFORNIA, THROUGH THE CALIFORNIA DEPARTMENT OF JUSTICE (BUREAU OF FORENSIC SERVICES)

(FOR ANALYSIS OF DNA SAMPLES USING THE EL DORADO COUNTY PROPOSITION 69 MONIES)

NO. 523-M111

This second amendment to the memorandum of understanding (MOU) for the analysis of DNA samples using the El Dorado County proposition 69 monies between the state of California, through the California Department of Justice (DOJ), Bureau of Forensic Services, and the County of El Dorado shall be entered into on the 1st day of June 2013.

This second amendment is for a time extension through May 31, 2014 from the first amendment of June 1, 2012 through May 31, 2013. The first amendment continued the original annual cost of a Senior Criminalist as \$164,198.00 (\$164,198/12=\$13,683.17 per month). This dollar amount is sufficient to cover the reimbursement of the second amendment as well. This extension will allow DOJ to continue the scope and services previously specified. The terms and conditions of the original MOU, other then the new dates, shall remain in effect until May 31, 2014.
