This extra work was not identified in the original Final 100% Remedial Design, provided to the County by the Forest Service, and therefore was not included in the original bid schedule.

While additional concrete lined channel was constructed, other design changes offset the anticipated additional costs, thereby negating the need for this funding. The contractor waives any claims for additional time or payment for the matters related to this Change Order.
