### AGREEMENT FOR SERVICES 017-S1410 AMENDMENT I

This Amendment I to that Agreement 017-S1410, is made and entered into by and between County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "Facility"), and Jones, Andrade, Boyd, Inc., doing business as (d.b.a.) Mar-Ric Care Home, whose principal place of business is 2749 Lindbrook Drive, Riverbank, CA 95367 (hereinafter referred to as "Contractor"), and whose Agent for Service of Process is Jaime Luz Andrade, 741 Foster Drive, Modesto, CA 95351.

#### RECITALS

WHEREAS, Contractor has been engaged by County to provide twenty-four (24) hour residential services for adults who have serious mental disorders (hereinafter referred to as "Client" or "Clients") in accordance with Agreement for Services 017-S1410 dated July 16, 2013, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to modify the term of this Agreement, thereby amending Article II – Term; and incorporate language pertaining to Government Code §8546.7, thereby adding Article XXXVI – Access to Records.

**NOW THEREFORE**, the parties do hereby agree that Agreement for Services 017-S1410 shall be amended a first time as follows:

1) Article II shall be amended in its entirety to read as follows:

**Term:** This Agreement shall become effective when signed by both parties hereto and shall cover the period July 1, 2013 through December 31, 2018.

2) Article XXXVI shall be added in its entirety as follows:

#### ARTICLE XXXVI

Access to Records: Contractor shall provide access to Federal, State, or County authorities to any books, documents, papers and records of Contractor which are directly pertinent to this specific Agreement for the purpose of making audit, examination, excerpts. an transcriptions. Contractor further acknowledges that contracts involving the expenditure of public funds in excess of \$10,000 are subject to examination and audits by the California State Auditor pursuant to Government Code Section 8546.7. In order to facilitate these potential examinations and audits, Contractor shall maintain for a period of at least three years or for any longer period required by law after final payment under this specific Agreement, all books, documents, papers, and records necessary to demonstrate performance under the Agreement.
