Mather Airport is located approximately 12 miles east of downtown Sacramento in the unincorporated portion of Sacramento County south of the City of Rancho Cordova. The airport occupies approximately 2,253 acres and is surrounded by a mix of land uses including: residential, commercial, industrial and open space.
