Mather Airport Expansion

I am writing to express my concerns regarding the Revised Draft EIR for the Mather Airport expansion and how it will effect outlying areas, especially an area of El Dorado County.

As a longtime resident of Coloma, CA, I have experienced the lull resulting from the Mather base closure and then the increased air cargo flights over our house..

First there have been no noise studies here in the Coloma Valley. Being in a narrow river canyon, the overflight noise at times is greater than the background noise from whitewater rapids of the American River. The reverberation is so great that, in a newly built home with dual pane windows and excellent insulation, it seems that a freight train is coming at you.

The State of California's Marshall Gold Discovery Park, the place where gold was first discovered, is our neighbor.

As part of the Fourth Grade California History program, over a seventy thousand fourth grade students visit the living history programs at the park each year. I have witnessed on numerous occasions when the Docents must stop their talk to let the noise from the air cargo transport plane pass. Should our State's heritage be diminished by the disruption from the current and proposed increased air cargo flights to and from Mather?

The Coloma Valley, Marshall Gold Discovery State Park and the American River corridor running down and into Lake Folsom is now experiencing fall and winter visits of the Federally protected Bald Eagle into its historic habitat. US Fish and Wildlife and Cal Fish and Wildlife should make comments to this aspect of the DEIR as well.

Reviewing the DEIR document, I've found no review of the fact that State Hwy. 50 functions at CALTRANS Level "F" in the area near the airport. This is the lowest


level of service measurable due to gridlock during peak and other measurable times. The additional medium and heavy truck traffic generated by the proposed expansion should be address in the DEIR.

I believe that the most logical course for Sacramento County would be to concentrate its air cargo operations at Sacramento International Airport where there is excess capacity for flights and traffic generated from the air cargo operations and <u>not</u> increase air cargo operations or upgrade to an ILS CAT 3 at Mather Airport.

While Mather Airport is in Sacramento County, its impacts are much farther reaching and these impacts to surrounding areas should also be taken into consideration when preparing a DEIR.
