# AMENDMENT TO WILLIAMSON ACT CONTRACT

Applying to El Dorado County Parcel APN 093-180-53, Tract 1 RS 25/120

The above referenced Williamson Act Contract shall be amended to incorporate and apply to the above referenced parcel as modified according to the parcel modification description detailed in EXHIBIT A, consisting of three pages which follow this page.
