

RESOLUTION NO.

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Whereas, County Ordinance Code Section 5.04.050 defines "carnival" as including the operation of any two or more of the following devices within five hundred feet (500') of each other: merry-go-round, ferris wheel, and carnival-type ride, shooting gallery or pony ride; and,

Whereas, the operation of a carnival in the County requires that the operator obtain a County Business License pursuant to County Ordinance Code Section 5.12.050; and,

Whereas, in order to obtain the business license, County Ordinance Code Section 5.12.050 requires the applicant to obtain a Resolution of the Board of Supervisors declaring that the public health, safety and welfare will not be endangered by the business at the location specified in the business license application, and, will not violate any zoning or health laws or regulations and to present a certified copy of the Board of Supervisors Resolution with the business license application; and,

Whereas, prior to adoption of any such resolution, the Board of Supervisors shall hold a public hearing on the matter and publish public notice of the time, place and purpose of which has been published in a newspaper of general circulation in the County at least ten (10) days before the hearing as required by County Ordinance Code Section 5.12.050; and,

Whereas, Wold Amusements, doing business as (dba) American Traveling Shows, has submitted a business license application with the Treasurer Tax Collector's Office to receive a Conditional Temporary Use Permit, and has supplied all that is required for the operation of a carnival within the South Lake Tahoe city limits, within El Dorado County, and is coordinating directly with the City of South Lake Tahoe for all necessary permits and conditions to safely operate the Kiwanis Community Fair on August 29, 2014 through September 1, 2014, at the Lake Tahoe Community College, located at One College Way, South Lake Tahoe, California, and that public notice was given on this hearing in accordance with County Ordinance Code Section 5.12.050.

Now, Therefore, Be It Resolved, by the Board of Supervisors for the County of El Dorado, that sufficient evidence has been presented of compliance with the requirements for the issuance of a business license for the operation of the Wold Amusements, dba American Traveling Shows, carnival at the Kiwanis Community Fair, and that the operation of the business does not endanger the public health, safety and welfare and does not violate any zoning or health laws or regulations.

Be It Further Resolved that the Board of Supervisors for the County of El Dorado hereby adopts this resolution for the approval of the business license submitted by Wold Amusements, dba American Traveling Shows, for the operation of a carnival at the Lake Tahoe Community College for the 2nd Annual Kiwanis Community Fair on August 29th through September 1st, 2014.
