Members of the Board.

On behalf of the hundreds of supporters of the Animal Shelter Coalition for El Dorado County, I urge you to consider the following as you review, again, Animal Services functions and the long overdue permanent Western Slope Animal Shelter project.

First, In July 2010 your Board authorized the permanent shelter to move ahead and directed staff to complete Phase 1 construction – the site improvements. That was the right decision. While we've seen no progress yet on Phase 1, we are hopeful that commitment will be carried out soon. The need for the permanent shelter has not diminished. There is no other shelter on the West Slope for the number and variety of animals housed. Shelter operations remain in an undersized, worn out rental building, four years after moving to this stop gap location. We are experiencing the best bidding climate public agencies have seen for years, your current lease will expire in 2013, and even if the building did not have clear shortcomings, the temporary shelter simply cannot remain in that location long term.

Secondly, we know that the need to shelter animals in custody arises in great part from the essential services and mandated activities carried out by Animal Services Officers as they enforce a variety of State Codes and local ordinances. They respond to thousands of calls each year, including loose animals, animal bites, aggressive dogs, and neglect complaints. Many of these calls result in animals in the custody of the Animal Services Division including mandatory stray/hold animals, potentially dangerous dogs, animals in protective custody pending court cases, and animals that must be quarantined.

Third, the Animal Services Division receives thousands of hours of volunteer support each year. We believe that should be recognized and valued. We also ask you to recognize that: 1) in order for these volunteers and the multiple non-profit animal welfare organizations to make their contributions to this County service, an adequate, appropriately sized and designed permanent shelter needs to be in place; and 2) the Division's field services, enforcement, and mandatory sheltering activities are appropriately carried out by trained Animal Services Officers and shelter employees.



Dear Supervisors Knight, Nutting, Sweeney, Briggs, and Santiago, I see that you're about to have your third workshop on Animal Services. I won't be able to attend, but I do want to speak up on this topic.

Regarding Animal Services:

- The total budget for AS is about \$2 million. Fees charged cover about 50% of that budget, leaving a total cost to the county of \$1 million. Compare this to the approximately \$40 million cost of the Sheriff's Department. In my opinion, you've spent far too much time "studying" a relatively low cost department with very little fat to trim. One wonders if there is some hidden agenda.
- The duties of Animal Services are largely mandated by law. I have in front of me a list which cites examples from the Penal Code, the Civil Code, the Food/Ag Code, the Health/Safety Code, and at least four County ordinances. One wonders why anyone would question the need to perform mandated services.
- Sheltering quarantined, abused, and abandoned animals is not just "nice to do". It is a basic and important public service, a county responsibility, and an appropriate use of public resources. One wonders why any reasonable person would question the need to provide this service.
- Animal Services shelters about 3,000 animals annually. There is no nonprofit in this county that is in a position to take on this responsibility. This point has been made over and over! One wonders why this notion keeps surfacing despite its obvious impracticality.

Regarding the Animal Shelter Project:

- The BOS recognized some time ago that there would be a need for a permanent, central facility for Animal Services, and, wisely, set aside the money to build such a facility. The need is now urgent, as the lease on the current two locations is coming to an end.
- The county has already purchased property, done an environmental assessment, and paid for a design. The county has also incurred an obligation to build an access road regardless of whether it builds on the property or not.

- We are now experiencing the best bidding climate public agencies have seen for years.
- Using project funds to temporarily close an operating budget gap is fiscally irresponsible. The gap will resurface within a year, and there will still be no Animal Shelter, and no hope of ever building one. The most objective and fiscally savvy folks in the county—two successive CAO's—have supported using the project funds as intended, and have warned of the folly of raiding them to put a band aid on the budget. One wonders why this is so hard for some folks to understand. It's not rocket science.
- Last summer, after a very thorough review of the project, and much discussion and debate, the BOS voted 3 to 2 (Thank you Supervisors Knight, Briggs and Santiago!) to move forward with the Animal Shelter project. One wonders why there is any discussion at all at this point.

Regarding the hidden agenda:

It's not about the budget. It's about pandering to a small but vocal and persistent group of anti-government extremists. My message to them: You have a right to your opinions. You have a right to be heard, and you have been—over and over! Your arguments have been refuted by fact and reason—over and over. Now sit down, be quiet, and let the rest of us do the best we can to build and maintain a civil and humane society. My message to the BOS: Please get on with implementing the decision you've already made to build a much needed Animal Shelter with the funds that have been set aside expressly for this purpose. Please let the hard working Animal Services staff do their very necessary work without further harassment.

In conclusion, I realize that the County has serious budget issues to contend with, and there are difficult decisions to make about the best use of slim resources. However abandoning any of the county government's responsibilities is not an option. I expect my government to be a government. And I, for one, and willing to pay my fair share to ensure that it can be.

The animal shelter has been in leased temporary facilities for its entire existence. Every time the lease expires there are multiple additional costs to the tax payer to create a new temporary shelter in a different leased facility.

It isn't like establishing a new office space where you can move in desks, chairs, a phone and computer system and then employees. An animal shelter has special needs. It needs kennels, special heating and air conditioning units to filter diseases, it needs to be easily cleaned to prevent diseases with a special drainage system. It needs an isolation area for all of the new arrivals to be kept separate from the healthy cats & dogs. It needs a large exercise area to keep the dogs healthy and sociable. Dear Supervisors Knight, Nutting, Sweeney, Briggs, and Santiago, I see that you're about to have your third workshop on Animal Services. I won't be able to attend, but I do want to speak up on this topic.

### **Regarding Animal Services:**

- The total budget for AS is about \$2 million. Fees charged cover about 50% of that budget, leaving a total cost to the county of \$1 million. Compare this to the approximately \$40 million cost of the Sheriff's Department. In my opinion, you've spent far too much time "studying" a relatively low cost department with very little fat to trim. One wonders if there is some hidden agenda.
- The duties of Animal Services are largely mandated by law. I have in front of me a list which cites examples from the Penal Code, the Civil Code, the Food/Ag Code, the Health/Safety Code, and at least four County ordinances. One wonders why anyone would question the need to perform mandated services.
- Sheltering quarantined, abused, and abandoned animals is not just "nice to do". It is a basic and important public service, a county responsibility, and an appropriate use of public resources. One wonders why any reasonable person would question the need to provide this service.
- Animal Services shelters about 3,000 animals annually. There is no nonprofit in this county that is in a position to take on this responsibility. This point has been made over and over! One wonders why this notion keeps surfacing despite its obvious impracticality.

#### **Regarding the Animal Shelter Project:**

• The BOS recognized some time ago that there would be a need for a permanent, central facility for Animal Services, and, wisely, set aside the money to build such a facility. The need is now

urgent, as the lease on the current two locations is coming to an end.

- The county has already purchased property, done an environmental assessment, and paid for a design. The county has also incurred an obligation to build an access road regardless of whether it builds on the property or not.
- We are now experiencing the best bidding climate public agencies have seen for years.
- Using project funds to temporarily close an operating budget gap is fiscally irresponsible. The gap will resurface within a year, and there will still be no Animal Shelter, and no hope of ever building one. The most objective and fiscally savvy folks in the county--two successive CAO's-have supported using the project funds as intended, and have warned of the folly of raiding them to put a band aid on the budget. One wonders why this is so hard for some folks to understand. It's not rocket science.
- Last summer, after a very thorough review of the project, and much discussion and debate, the BOS voted 3 to 2 (Thank you Supervisors Knight, Briggs and Santiago!) to move forward with the Animal Shelter project. One wonders why there is any discussion at all at this point.

#### Regarding the hidden agenda:

It's not about the budget. It's about pandering to a small but vocal and persistent group of anti-government extremists. My message to them: You have a right to your opinions. You have a right to be heard, and you have been--over and over! Your arguments have been refuted by fact and reason--over and over. Now sit down, be quiet, and let the rest of us do the best we can to build and maintain a civil and humane society. My message to the BOS: Please get on with implementing the decision you've already made to build a much needed Animal Shelter with the funds that have been set aside expressly for this purpose. Please let the hard working Animal Services staff do their very necessary work without further harassment.

In conclusion, I realize that the County has serious budget issues to contend with, and there are difficult decisions to make about the best use of slim resources. However abandoning any of the county government's responsibilities is not an option. I expect my government to **be** a government. And I, for one, and willing to pay my fair share to ensure that it can be.

Members of the Board,

On behalf of the hundreds of supporters of the Animal Shelter Coalition for El Dorado County, I urge you to consider the following as you review, again, Animal Services functions and the long overdue permanent Western Slope Animal Shelter project.

First, In July 2010 your Board authorized the permanent shelter to move ahead and directed staff to complete Phase 1 construction – the site improvements. That was the right decision. While we've seen no progress yet on Phase 1, we are hopeful that commitment will be carried out soon. The need for the permanent shelter has not diminished. There is no other shelter on the West Slope for the number and variety of animals housed. Shelter operations remain in an undersized, worn out rental building, four years after moving to this stop gap location. We are experiencing the best bidding climate public agencies have seen for years, your current lease will expire in 2013, and even if the building did not have clear shortcomings, the temporary shelter simply cannot remain in that location long term.

Secondly, we know that the need to shelter animals in custody arises in great part from the essential services and mandated activities carried out by Animal Services Officers as they enforce a variety of State Codes and local ordinances. They respond to thousands of calls each year, including loose animals, animal bites, aggressive dogs, and neglect complaints. Many of these calls result in animals in the custody of the Animal Services Division including mandatory stray/hold animals, potentially dangerous dogs, animals in protective custody pending court cases, and animals that must be quarantined.

Third, the Animal Services Division receives thousands of hours of volunteer support each year. We believe that should be recognized and valued. We also ask you to recognize that: 1) in order for these volunteers and the multiple non-profit animal welfare organizations to make their contributions to this County service, an adequate, appropriately sized and designed permanent shelter needs to be in place; and 2) the Division's field services, enforcement, and mandatory sheltering activities are appropriately carried out by trained Animal Services Officers and shelter employees.

Following this latest review of the Animal Services Division, we trust there will be a better understanding of the essential public safety services provided and the resulting need to shelter animals in custody, driven by those field services activities.
