## AGREEMENT FOR SERVICES #218-S1310 AMENDMENT IV

This Amendment IV to that Agreement for Services #218-S1310, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Architectural Nexus, Inc., a Utah Corporation, doing business as Anova Nexus, Inc., now operating as Architectural Nexus, Inc., a Utah Corporation, duly qualified to conduct business in the State of California, whose principal place of business is 2505 East Parleys Way, Salt Lake City, Utah 84106 and whose local place of business is 1990 Third Street, Suite 500, Sacramento, California 95811 (hereinafter referred to as "Contractor").

**NOW, THEREFORE,** the parties agree that Agreement for Services #281-S1310 shall be amended a fourth time to read as follows:
