AGREEMENT FOR SERVICES #627-S1310 AMENDMENT I

This Amendment I to that Agreement for Services #627-S1310, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Phil Dannaker, a private investigator, dba Mother Lode Investigations, duly qualified to conduct business in the State of California, whose principal place of business is 5581 Manzanita Lane, Placerville, CA 95667; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide investigation services on an as needed basis, in accordance with Agreement for Services #627-S1310, dated July 1, 2013, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement, hereby amending Article II Term, to extend the term of the original Agreement; and

WHEREAS, the parties hereto have mutually agreed to amend Article III Compensation for Services, to increase the maximum obligation of the Agreement;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #627-S1310 shall be amended a first time as follows:

ARTICLE II

Term: This Amendment shall cover the period of January 1, 2014 through June 30, 2014, unless terminated pursuant to the provisions under the Articles titled "Fiscal Considerations" and "Default, Termination and Cancellation" herein.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears and within thirty (30) days following the County's receipt and approval of itemized invoice(s) identifying services rendered. For the purposes of this Amendment the billing rate shall be \$47.50 per hour. Total amount of this Amendment shall not exceed \$54,400.00 (Fifty four thousand four hundred dollars) including expenses. Compensation for services under this Agreement shall not exceed \$108,800.00 (One hundred eight thousand eight hundred dollars).

Except as herein amended, all other parts and sections of that Agreement #627-S1310 shall remain unchanged and in full force and effect.
