	HE FOLLOWING CONDITIONS ARE REQUIRED FOR ALL ROAD CLOSURES:  The organizers shall provide a detailed signing and detour plan for any proposed closure of a					
	major county road. This signing/detour plan should identify the type and location of all signs, barricades, cones, and flaggers. The plan must be attached to this application when it is submitted for review.					
2.	2. The organizers shall provide proof that the owners of the adjacent <u>business along the road</u> <u>closure are in agreement</u> with proposed closure. These agreements must be attached to this					
3.	application when it is submitted for review.  The organizers shall be responsible for providing all signs, barricades, cones, flaggers, and					
	traffic controls and sanitation facilities.					

- 4. Wooden barricades shall be placed across the County road to close the road. Barricades shall
- also be placed across all intersecting roads to deny access to the closed road.
- 5. A "ROAD CLOSED" sign shall be placed at each barricaded intersection. Each sign shall measure at least 48 inches by 30 inches, with 8 inch black letters on a white background.
- 6. The organizers shall remove all signs, all pavement markings or other materials immediately following the event. The organizers shall also remove all debris deposited by participants and
- 7. The organizers shall provide a Certificate of Insurance in the amount of one million dollars, naming County of El Dorado, its officers, officials, employees and volunteers are included as additional insured, (ON AN ADDITIONAL ENSURED ENDORSEMENT) but only insofar as the operations under this agreement are concerned. This provision shall apply to the general liability policy.
- 8. To the fullest extent allowed by law the Organizer shall defend, indemnify, and hold the County harmless against and from any and all claims, suits, losses, damages, and liability for damages of every name, kind and description, including attorney's fees and costs incurred, brought for, or on account of, injuries to or death of any person, including but not limited to workers, County employees, and the public, or damage to property, or in anyway arise out of are connected with the work by the Organizer, his agents or employees including contractor's services, operation or performance hereunder, regardless of the existence or degree of fault or negligence on the part of the County, the Organizer, contractor, subcontractor(s) and employee(s) or any of these, except for part of the sole, or active negligence of the County, its officers and employees, or as expressly prescribed by statute. This duty of the Organizer to indemnify and save the County harmless includes the duties to defined set forth in California Civil Code Section 2778.

# Cowboy Gathering on the Georgetown Divide October 18 – 19, 2014

### Signing and detour plan

Main Street in Georgetown will be closed on both sides of the street from Hwy 193 to Placer Street beginning 6pm on Friday, October 17, until 7pm Sunday, October 19, to allow for set-up and break-down of the vendor area. In addition, Main Street will be closed on the North side of the street between Placer Street and School Street, for the safety of the wagon train, beginning 7am on Saturday, October 18 until 7pm on Sunday, October 19. The South side of Main Street between Placer and School Streets will remain open to local traffic going to the businesses located on that side of the street.

#### Traffic flow:

North and South bound traffic from Hwy 193 desiring to go east on Main Street will be routed on to Church Street, routed right on School Street, then left on Wentworth Springs Road; alternatively, cars will be routed on to South Street, left on Harkness, and right on Wentworth Springs Road.

Westbound traffic from Wentworth Springs Road will be routed right onto School Street, left on to Church Street, to Hwy 193.

Only cars with business at Worton's or Divide Auto Supply will be allowed to enter Main Street from Placer Street going in the northbound direction.

#### Barricades:

A-Frame barriers will be placed at 8-10 foot intervals with caution tape between them, in the following locations:

- Blocking Main Street at the intersection of Main Street and Hwy. 193
- Blocking Main street at the intersection of Main Street and Placer Street, on the West side of Placer Street
- Blocking the north half of Main Street, at the intersection of Main Street and Placer Street, on the east side of Placer Street.
- Blocking the north half of Main Street, at the intersection of Harkness Street and Main Street, on the west side of Harkness Street.
- Along the outside of the north side/east bound side of Main Street from Placer Street to Harkness (to keep cars from drifting across)

## Signs:

"Road Closed" signs, each measuring 48 inches by 30 inches, with 8 inch black letters on a white background, will be placed in the following locations:

- Main Street at the intersection of Main Street and Hwy. 193
- Main street at the intersection of Main Street and Placer Street, on the West side of Placer Street
- Main Street, at the intersection of Main Street and Placer Street, on the east side of Placer Street.
- Main Street, at the intersection of Orleans Street and Main Street, on the west side of Orleans street.
- Main Street at Harkness
- Main Street, at School (west bound closed)

"Detour" signs will be placed in the following locations:

- Corner of Hwy. 193 and Church Street
- Corner of Hwy. 193 and Main Street
- Corner of Church Street and Placer Street
- Corner of Church Street and Orleans Street
- Corner of Church Street and Harkness Street
- Corner of Church Street and School Street
- Corner of Main Street and Harkness Street
- Corner of Main Street and School Street
- Corner of South Street and Orleans Street
- Corner of Wentworth and School Street

"Local traffic only" signs will be placed in the following locations (to keep cars on Main Street to a minimum):

Corner of Church Street and Placer Street

#### Flaggers:

A flagger will be located at the following locations to direct traffic:

- Corner of Hwy. 193 and Church Street
- Corner of Hwy. 193 and Main Street
- Corner of Church Street and Placer Street
- Corner of Church Street and Harkness Street
- Corner of Main Street and Harkness Street
- Corner of Main Street and School Street

Coverage Limits: \$1,000,000 per Occurrence

It is hereby agreed that this endorsement is added to the Liability Coverage Agreement issued to Georgetown Divide Recreation District by Special District Risk Management Authority ("SDRMA") adding the following as an Additional Covered Party.

The County of El Dorado, its officers, officials, employees and volunteers are named as additional covered parties pertaining to the road closures for the Garden Valley Annual 4th of July Parade and Celebration, the Cowboy Gathering on the Georgetown Divide event, annual Halloween event and for use of parking lot for the "National Night Out" event.

The coverage afforded by this ENDORSEMENT shall be primary with respect to any other valid and collectible insurance El Dorado County may possess, including any self insured retention El Dorado County may have, and any other insurance El Dorado County does possess shall be considered excess insurance only and shall not be called upon to contribute with this coverage but only with respect to liability arising out of the ongoing operations of the Member Agency named above and provided further that this coverage does not apply to the sole negligence of the additional covered party named above. Coverage shall not be extended for the active negligence of the additional named party in any case where an agreement to indemnify the additional named party would be invalid under Subdivision (b) of Section 2782 of the Civil Code.

All other terms and conditions remained unchanged.

Coverage provided by this endorsement, under the terms, conditions and exclusions contained in the Liability Coverage Agreement issued by SDRMA to Georgetown Divide Recreation District shall not be reduced or canceled without thirty (30) days written notice given to the El Dorado County via certified mail.

#### THIS ENDORSEMENT CHANGES THE LIABILITY COVERAGE AGREEMENT. PLEASE READ IT CAREFULLY.

The inclusion of more than one Covered Party shall not operate to impair the rights of one Covered Party against another Covered Party and the coverages afforded shall apply as though separate policies have been issued to each Covered Party except that the inclusion of more than one covered party shall not increase the limit of liability of SDRMA.
