Dear Mr. Cherry and Board Members,

My name is Peter Nelligan. I am a permanent resident and property owner in the Tahoe Paradise Park Resort Improvement District. I understand that there may be a vacancy in the near future on the Board of Directors of the district. Please accept this letter as an expression of interest in and statement of qualifications for appointment to the board.

My interest in Tahoe Paradise Park began in 2011 when my wife and I purchased a small cabin in the North Upper Truckee neighborhood. We were pleased to find such a beautiful park close to our cabin. However, when I visited the park, I perceived that it could benefit from improvements in appearance, maintenance, and operations. In speaking with neighbors and others I met in the community, I found much misinformation about the park as well as some negative perceptions of it.

When we retired in 2013 and moved permanently to a new residence in the district, I began attending board meetings and seeking information about the park. At these meetings I encountered several other residents with similar concerns. Through a series of conversations we developed a comprehensive list of "Issues and Concerns" that we provided to the board. The board has been receptive to these overtures, and appears to appreciate the interest and energy that has been forthcoming. The board has created several committees to work on various issues and projects. I have been appointed vice-chair of the Master Plan Committee and a member of the Governance Committee. Board members and other volunteers seem to value my contributions. The "Issues and Concerns" document that I drafted has evolved into the core statement of goals and objectives for the draft of a new master plan for the park.

By way of personal and professional background that may be of relevance, let me provide a brief overview. My main career has been academic. I earned a Ph.D. in sociology (emphasis in criminology and criminal justice) at the University of Hawaii in 1983. Subsequently, I held faculty positions and earned tenure at the University of Texas at Tyler and at California State University Stanislaus, achieving the rank of full professor. At UT Tyler I held the Brooks Endowed Professorship in Ethics and Leadership. At CSU Stanislaus, I was the director of the Master of Arts in Criminal Justice Program. Upon retirement from CSU Stanislaus, I was awarded the status of "Emeritus Professor of Criminal Justice," an honor conferred by both peers and administrators.

During my academic career I taught many courses, some of which may be relevant to the park. Most notable is a graduate course in "Policy Analysis and Program Evaluation," and other courses in research methods. I have already found these insights and skills useful in analyzing park issues. I assisted in the development, administration, and analysis of a community survey related to the master plan. I have

excellent writing skills, as evidenced by published book chapters and articles in peer reviewed journals. I have experience with grant writing and grant execution. Finally, during my academic career I served on or chaired dozens of faculty, administrative, and community committees. I have a long history of working well with others with sensitivity to inclusive and deliberative processes while getting the work done.

My interest in and attraction to parks goes back decades. I was fortunate to have parents who took me to national, state, and local parks as a child. While I was an undergraduate in college, I worked part time for the California State Park System, first as a park aid at Sugarloaf Ridge State Park (1967-68) in Sonoma County and as a California State Park Ranger (permanent intermittent) at Carpinteria State Beach (1968-71). Through these experiences I developed and retain a strong appreciation of parks of all kinds for wonderful recreational experiences and sites for the appreciation and preservation of nature.

If appointed to the Board of Directors of Tahoe Paradise Park Improvement District, I pledge to use my time, energy, and skills to help move the park forward to be the recreational and nature resource the community deserves.
