Dear Board of Supervisors,

As a member of the Board of Trustees for the Marshall Foundation and a member of the Community Gifts Cabinet for the Cancer Center Campaign, I kindly ask that you approve an \$800,000 contribution from the revenues that have accrued from the Tobacco Settlement funds. I understand that the County must provide for a wide range of residents' needs and must prioritize a finite share of funding to meet those needs. However, as one of the County's largest employers, Marshall Medical Center is the only provider of emergency and inpatient care on the Western Slope and functions in place of a county-operated hospital. The funds we raise will bring the Cameron Park Cancer Center to fruition, and consolidates diagnostic and treatment services for those in our community who are battling a terrible disease that not only takes its toll on the patient, but their family as well.

According to the American Cancer Society, lung cancer is the leading cause of cancer-related deaths among men and women. Designating Tobacco Settlement Funds ensures the construction of the Cancer Center and aligns perfectly with the spirit and intent of the settlement.

On a personal note, my grandmother passed away from lung cancer because we did not catch it in time to formulate an effective treatment plan. Your approval of the \$800,000 contribution sends a very strong message to your community that you support Marshall Medical as our local health care provider and allows them to enhance the scope of their services to provide early cancer detection and treatment, which is critical in a patient's prognosis.
